Position Overview

The Student Learning Growth and Engagement Coordinator is dedicated to nurturing and enhancing student achievement across the college. Central to this role is a commitment to identifying and responding to learning needs through data-informed analysis, pedagogical support, and literacy enrichment. By working collaboratively with Curriculum Leaders and subject teachers, the Student Learning Growth and Engagement Coordinator cultivates targeted teaching practices and data-informed strategies that foster meaningful learning growth across cohorts, curriculum areas and student profiles. Grounded in care and evidence, this role drives initiatives that elevate student progress, reduce barriers to learning, and foster a culture of high expectations and continuous improvement.

Catholic Identity and Mission

- · Promote the ethos, mission and strategic goals of Marian College and Kildare Ministries
- Support the College's values, policies and procedures through visible and relational leadership
- Nurture student learning growth through equity-focused strategies and responsive teaching, affirming each learner's dignity and capacity to flourish.

Leadership and Vision

- Provide a strategic and visionary approach to student growth across the College, informed by educational data, pedagogical research and Gospel values
- Work collaboratively with Curriculum Leaders, the Head of Learning and Teaching and classroom teachers to implement programs that foster learning growth across disciplines and year levels
- · Model empathy, perseverance, patience and professionalism in all relationships
- Actively support decisions made by the College Leadership Team.

Pastoral Care

- Work closely with House Leaders, the Senior School Coordinator and subject teachers to reduce the risk of student underperformance
- Promote strength-based approaches to learning intervention, fostering student confidence and engagement
- Ensure that strategies supporting student growth are inclusive, compassionate and aligned with pastoral care practices that reflect the values of Marian College.

Academic Progress and Student support

- · Analyse student performance data to identify areas of need across cohorts and curriculum areas
- Support literacy and numeracy development through explicit teaching resources and individualised staff coaching.

Staff Leadership and Development

- Facilitate professional learning opportunities, including Professional Learning Teams (PLTs), focused on data-informed pedagogy, explicit teaching, literacy and intervention
- Provide one-on-one pedagogical mentoring to teachers to develop differentiated responses to student learning needs
- · Model relational leadership that supports teacher capacity, professional dialogue and collaborative learning
- · Contribute to a culture of reflective practice and continuous growth within teaching teams.

Communication and Engagement

- Build strong, respectful relationships with staff to support collaborative teaching practice and shared responsibility for student growth
- Partner with Curriculum Leaders and the Head of Learning and Teaching to ensure interventions and pedagogical support are embedded across the school
- · Celebrate student achievement and progress through whole-school events, newsletters and staff forums
- Communicate outcomes of learning programs and academic support through clear and timely feedback mechanisms.

Specific tasks

- Monitor and respond to trends in student performance using NAPLAN, ACER- PAT M & PAT R, and internal school data sets eg. data from subject specific online platforms
- In collaboration with the Head of Learning and Teaching and working with subject teachers and Curriculum Leaders, analyse and respond to VCE data.

Commitment to Child Safety
